Effective October 1, 2014 ICD-9-CM is being replaced with ICD-10-CM coding system. This will require a transition from 14,000 codes to 68,000 codes. This will allow for greater precision and specificity.

Claims for all services performed on or after October 1, 2014 in Long Term Care must use ICD-10-CM. Claims that do not use ICD-10-CM codes cannot be processed. With the challenging times we face in our industry we cannot afford not to insure our staff responsible for coding is well prepared for this transition.
